

## Supreme Chaplain's Message

hakespeare places on the lips of the star-crossed lover Juliet a question: "What's in a name?" She goes on to say, "That which we call a rose by any other name would smell as sweet."

We may ask ourselves this same question – "What's in a name? – about a powerful group that now goes by the name "Compassion & Choices." Judging only by the name, it sounds like a good-hearted organization. After all, who would oppose compassion or helping people know and understand their options?

In reality, Compassion & Choices is not a new organization but an old one that formerly went by the name Hemlock Society. Hemlock was the poisonous drink that ended the life of the philosopher Socrates. The old name tells us much more about the nature of the organization, which is dedicated to legalizing doctor-assisted suicide. The compassion it offers is suicide. The choice it offers is death.

Wearing its new, Orwellian moniker, Compassion & Choices has mounted a formidable campaign to legalize doctor-assisted suicide throughout the United States and beyond. The group turns up in community health fairs and public libraries. Well-funded and politically savvy, it has recently succeeded in California, Colorado and Washington, D.C. In 2017, the

organization is targeting Maryland, New Jersey, New York, Connecticut, Rhode Island, Maine, Minnesota and Hawaii.

Let us make no mistake: Compassion & Choices is out to legalize doctor-assisted suicide throughout the United States. We can also be sure that these proponents of what Pope Francis calls the "throwaway culture" will share their playbook, so as to spread their deceptive message throughout the world.

As we prepare once again to march for the cause of life, let us also focus on how we should respond to this unfolding threat to the life and dignity of the frail elderly, the terminally and chronically ill, the handicapped, and those who suffer from depression. Just as we seek to protect the lives of unborn children and to reach out to their mothers with genuine compassion, so too we must reach out as never before to the vulnerable, protecting their lives and dignity against the onslaught of doctor-assisted suicide.

The starting point for our efforts is confidence in the Church's teaching on the dignity of human life from the moment of concep-

tion until natural death. This teaching corresponds to a deep-seated instinct in every person

to preserve his or her own life. Indeed, "we are the stewards, not the owners, of the life God has entrusted to us" (Catechism of the Catholic Church, 2280).

To be sure, many people, if asked, would support physician-assisted suicide because they value the ability to control one's destiny – and because they think it is the only way to end suffering. But many others rightly believe that life is God's precious gift to be respected and that we are called to live each day with dignity. Helping those who are handicapped, sick or dying to take their own lives is morally unacceptable. Instead, we are encouraged to alleviate their sufferings and to walk with them in love until the moment of natural death.

So, let us be bold, courageous and loving in pointing out how uncompassionate doctor-assisted suicide really is.

True compassion – literally, suffering with – seeks to ease suffering while accompanying those who suffer. We seek to kill the pain, not the patient. True compassion

also requires us to speak plainly, not using camouflaged terms such as "aid-in-dying" but rather pointing out that Compassion & Choices advocates for "doctor-prescribed" or "doctor-assisted" suicide. When people realize that the real issue here is suicide, their minds and hearts are often changed.

Second, legalized doctor-assisted suicide sends a message to the suffering. It tells them that their lives are a burden to society and that the world would be better if they were dead. Is there a message more likely to make the suffering feel isolated, hopeless and disconnected? Their pain is surely compounded when family members and friends send this signal.

Third, assisted suicide can also traumatize loving families. The very thought that a sick, elderly or disabled member could take his or her own life without their even knowing about it horrifies many families, and there is no requirement that they be notified before the lethal dose is prescribed.

Fourth, studies show that in places where doctor-assisted suicide is legalized,

commitment to palliative care declines. Government programs and insurers save money when the life of the suffering patient is simply ended. In other words, suicide is a cheap answer to pain. We should demand that health care programs provide truly compassionate care that eases the pain of the sick and dying.

Fifth, the promise of freedom of choice is an illusion. Doctors can prescribe lethal doses of drugs without knowing whether the patient is clinically depressed. Also, once the lethal drugs leave the pharmacy they are within easy reach of those who would abuse the elderly and the disabled, since no oversight or witnesses are required.

Finally, studies show that once suicide is legalized as good for some, the overall number of suicides dramatically increases.

The Order is blessed to number among our members many medical professionals and those who work with and advocate for the disabled and elderly. I encourage you, as well as all Knights, to oppose doctor-assisted suicide legislation in your jurisdictions. That's true compassion. That's the right choice.



Prothers all, The Feast of Epiphany is preceded in importance by only three other feasts during the liturgical year. (As a good exercise, see if you can name the three feasts in order of their liturgical importance.) The connection between Epiphany and Christmas is not only in the fact that it is twelve days after the celebration of Christ's Nativity, but also in its modern emphasis on the visitation of the Magi to the Christ Child. Historically, however, the connection is stronger still. Laurence Paul Hemming, when describing the history and theological significance of Epiphany in his book *Worship as Revelation*, reminds us that

the feast of Christ's birth was originally celebrated on January 6 rather than the current date of December 25.

The Feast of Epiphany calls us to contemplate our own creation and its orientation to our new creation in Christ Jesus. While we may at first be drawn to thoughts of the three gifts of gold, frankincense, and myrrh, the true gift of Epiphany is Christ's gift of himself for our salvation. Therefore, the three gifts offered by the Magi should

only be representations of our own gift of self to the Lord. The universal call to holiness means that the mystery of Christ must become the center of our own existence. As with all things liturgical, the event of Epiphany effects what it signifies. While signifying our own divinization, the liturgy also brings about that divinization.

Truly, through our Eucharistic participation in his incarnation-death-resurrection, we do "come to share in the divinity of Christ who humbled himself to share in our humanity." However, like all sacramental effects, we must dispose ourselves towards the reception of the grace offered. Our attitude towards our Creator must first and foremost be that of openness to the gift, an attitude that recognizes the transcendent reality beyond us, that sees with the eyes of faith that we are actors in the great drama being played out in the cosmos. Let us pray for this disposition so that Jesus Christ might become an Epiphany in our own lives.

## Reflections

#### WINNING IS NOT THE SAME AS VICTORY

n September 18, 1862, after the previous day's fierce fighting, Gen. Robert E. Lee withdrew his battered army from Antietam and retreated to Virginia. The superior Union forces under the command of Gen. George B. McClellan had an opportunity to re-engage and destroy the Confederate army and possibly end the war. McClellan, however, did not pursue and Lee was able to reconstitute his forces and fight for another two and a half years. On November 8, 2016, pro-life voters helped defeat an anti-life, anti-religious freedom candidate for president. The triumphant Presidentelect has named a Cabinet that may be the most favorable toward life, traditional marriage and religious liberty in the history of this nation, and has promised to nominate Supreme Court justices who are pro-life and believe in constitutional originalism rather than judicial activism. The designated-nominee for: Secretary for Health and Human Services has a one-hundred percent congressional voting record on pro-life issues; Secretary of Education has received strong endorsements from national pro-life groups; Attorney General is a protector of religious liberty; and Secretary of Defense is a champion of the persecuted Christians in the Middle East.

But leaders need supporters, just as generals need troops and politicians need constituents. If a culture of life is to once again guide the policies of this nation, continued pro-life action is needed. Passivity, timidity and false compromise after this electoral success will assure that much of the current policy remains unchanged. President Barack Obama has pursued a strong irreligious agenda from virtually the first to the last day of his eight-year administration. Three days after his inauguration in January 2009, he rescinded the Mexico City Policy, originally enacted in 1984. The regulation prohibited private organizations that received U.S. foreign aid from performing or promoting abortions abroad. His secularist policies continued unabated increasing federal funding for abortion; imposing mandates that force religious organizations and family-owned businesses to pay for abortioninducing drugs, contraception, and sterilization in their healthcare plans; promoting LGBT privileges; creating gender self-identity rights; declaring that Catholic colleges, hospitals and social service agencies that hire and serve non-Catholics do not qualify for a religious exemption from certain government regulations; cancelling grants to Catholic programs that provide relief

to the victims of human trafficking because the Church opposes abortion; and not defending against legal challenges to the Defense of Marriage Act which defined marriage as the union of one man and one woman.

This godless pursuit continued through December 15, 2016, when the Department of Health and Human Services adopted a rule to prevent states from prohibiting federal funds appropriated for family planning under Title X of the Public Health Service Act from going to Planned Parenthood and other abortion providers. The rule takes effect January 18, two days before President Obama's term ends.

Planned Parenthood, which performed 30.6 percent of all abortions in the United States in 2015, has enjoyed a favored relationship with this Administration. In the past eight years, its federal funding increased from \$363 million in 2008 to \$554 million in 2015.

President-elect Trump and the Republican Congressional leadership have stated that a bill to defund Planned Parenthood and dismantle Obamacare will be one of the first items on the agenda after the inauguration. The funds currently going to less than 665 Planned Parenthood facilities will be awarded to some 13,540 Federally Qualified Health Centers, which do not provide abortions, and thus will increase public access to health care services such as pap smears and breast exams.

The effort to defund Planned Parenthood is not only a financial imperative, but a moral one as well. In December 2016, the U.S. Senate Judiciary Committee referred several Planned Parenthood affiliates to the FBI and the U.S. Department of Justice for possible prosecution for illegally selling body parts from aborted infants.

With the change in the presidency, a radical opposition will employ every political maneuver and public relations ploy to preserve -- and even expand -- the anti-Christian, anti-life, anti-family executive orders, laws, regulations, and policies of the outgoing Administration.

LGBT activists are working to legally protect "sexual orientation and gender identity." These measures, referred to as SOGI, would empower the government to use the force of law to punish individuals and organizations that act on their religious convictions. Under these decrees, persons could incur fines, jail time and personal ruin, and organizations be threatened with the loss of grants, contracts, licensing and tax-exemption. Already, the Education Department has interpreted Title IX to require schools and colleges under non-discrimination statutes to allow students access to bathrooms and locker rooms based on their claimed gender rather than their birth sex.

The first 100 days of a new presidency are most important for getting things done. Executive branch actions are not laws and thus a new president can abolish previous ones by a stroke of a pen. It is expected that after he is inaugurated, President Trump and his HHS Secretary Tom Price, working in collaboration with majorities in both Houses of Congress, will not only repeal the Obama actions but enact new legal protections for the most vulnerable members of society.

In addition, the new President, his Cabinet, and Congress should act quickly to:

- Eliminate regulations in the military and federal agencies that criminalize Christian beliefs on sexuality, marriage and religious expression
- Overturn the Obamacare mandate that requires faith-based organizations to provide employee healthcare insurance that supports sterilization, contraception and abortifacients
- Repeal regulations that force schools and businesses dealing with the public from allowing people to use bathrooms and changing rooms based on one's preferred gender
- Nominate and confirm a pro-life justice to the Supreme Court Electing a pro-life president was a success. But it is a dangerous assumption to consider this as the desired victory. We who are pro-life, pro-family and desire religious freedom must continue to pray and must support our political representatives in upholding their campaign promises. We must turn the success of the recent hard-fought election campaign into a complete victory and re-establish a culture of life in this nation.

Don't forget the March for Life is quickly approaching. Let's show everyone that Maryland is Pro Life and be in DC on



# THE SUPREME COURT'S INFAMOUS 1973 ABORTION DECISION REMAINS AN UNSETTLING — AND UNSETTLED — ISSUE

s a special assistant to President Ronald Reagan in 1986, I was privileged to work on the nomination of Antonin Scalia to be a member of the U.S. Supreme Court. At the time, I could not imagine that 30 years later we would be considering a new nominee to fill the vacancy resulting from his untimely death.

President Reagan had pledged to appoint judges who respect "the sanctity of innocent human life." Americans knew his language was to be understood in light of his repeated criticism of the Supreme Court's 1973 abortion decision in Roe v. Wade. With the nomination of Justice Scalia, he kept his promise, and Scalia was unanimously confirmed by the Senate.

Whenever there is a Supreme Court vacancy, we are told by supporters of Roe v. Wade that the decision is "settled law." But such supporters face this difficulty: Roe v. Wade will never be settled law, because Roe v. Wade is founded on the lie that we

do not know that the victim of every abortion — an unborn child — is a human being.

There is another difficulty as well: Since Roe v. Wade, millions of women have concluded that instead of being helpful, abortion is deeply hurtful.

In America, judicial decisions that are contrary to the dignity of the human person simply cannot be sustained over time. This is the lesson we learned long ago from those tragic court decisions which held that African-Americans were not entitled to the equal protection of our laws.

Roe v. Wade will never be settled constitutional law as long as Americans say, "It is not settled."

This was precisely the approach President Abraham Lincoln took regarding the Supreme Court's 1857 decision in the Dred Scott case and laws on slavery. It was the right approach then, and it remains the right approach today.

Virtually unrestricted abortion continues to be morally unsettling for a majority of Americans. More than four decades after the Supreme Court handed down its decision, abortion

remains one of our most controversial issues.

At the time, Justice Byron White called the court's decision in Roe v. Wade an exercise of "raw judicial power." His dissenting opinion remains one of the strongest critiques of the case. Appointed by President John F. Kennedy, Justice White continued to be a strong critic of Roe v. Wade during the 20 years he remained on the Supreme Court.

He later wrote, "The Judiciary, including this Court, is the most vulnerable and comes nearest to illegitimacy when it deals with judge-made constitutional law having little or no cognizable roots in the language or even the design of the Constitution."

"Raw judicial power" has not convinced Americans that Roe v. Wade is right.

In recent years, our Knights of Columbus-Marist polling has consistently shown that more than 8 in 10 Americans would limit abortion — at most — to the first three months of pregnancy. Almost 6 in 10 would limit it — at most — to cases of rape or incest or to save the life of the mother, and that includes the majority of Americans who describe themselves as "pro-choice."

Almost two-thirds of Americans say that our abortion rate is too high. And 6 in 10 Americans continue to believe that abortion is morally wrong.

During my address to last year's Supreme Convention, I stated that we will never build a culture of life if we continue to elect public officials who defend a legal regime of unrestricted abortion. The same must be said of those who are appointed as our judges.

As we look ahead to how the new president will keep his promise to be pro-life, we remember the words of the current occupant of that office who at the beginning of his administration famously said, "Elections have consequences."

When it comes to defending the lives of millions of unborn children, we sincerely hope so.

## 2 good reasons to move IRA funds to permanent life insurance

Clients want guarantees, growth, control, safety, protection, access, liquidity and low taxes. Here's how to do all of that.

A large IRA sounds good, but it may be too much of a good thing. The larger an IRA balance grows, the greater the retirement debt that will be owed in taxes.

The IRA problem

If at all possible, debt should be eliminated before retirement. The retirees who are debt-free are proud of that fact. To most people, being debt free means having no more home mortgage, having no credit card debt and not owing any money to anyone.

But if they have a large IRA or other tax-deferred retirement account, they actually have a looming debt to the IRS. As that IRA grows so does that debt, just like an unpaid credit card, compounding as the account value increases.

While the tax debt is deferred, the deferral is limited due to required minimum distributions (RMDs) that force the taxes out with withdrawals beginning after age 70 ½. The problem with this retirement debt: Unlike the interest rate on a home mortgage, the tax rate on future IRA withdrawals is unknown.

That creates uncertainty, especially when it is likely that tax rates will increase. And they will be based on a larger balance the longer the IRA is left to grow tax-deferred.

Unlike other non-IRA type investments, funds in IRAs and 401(k)s at death remain taxable. There is no step-up in basis, as there would be for a highly appreciated stock held outside of an IRA, eliminating the income tax at death. IRA and 401(k) beneficiaries are subject to tax on post-death RMDs.

In addition, if the estate including the IRA is large enough, the IRA can be subject to estate taxes as well. In that case, there is a corresponding tax deduction (the deduction for income in respect of a decedent), but only for federal estate taxes, not state estate taxes.

IRA funds are often invested in the stock market, so they are also subject to that market risk. Traditionally, the stock market increases over time, but if the market declines when retirement funds are needed, less of the remaining funds are available for future growth. This is the classic sequence of returns risk that depletes needed retirement funds.

On the contribution side, annual IRA contributions are limited to small amounts (\$5,500 per

year or \$6,500 for those ages 50 and over). Plus contributions for traditional IRAs are no longer permitted once the client reaches age 70  $\frac{1}{2}$ . For all of these issues, large IRAs are in fact a poor retirement vehicle. There are too many risks and uncertainties. That is not a good foundation for a long-term retirement plan.

When asked, most clients approaching or in retirement want more certainty. They also want guarantees, growth, control, safety, protection, access, liquidity and low or no taxes. But most of all, they want to sleep at night.

They want peace of mind. Large IRAs will not provide that, but these IRA funds can be leveraged to gain all of that by transitioning those funds to a permanent life insurance policy. When IRAs grow too much, they need to be trimmed. Yes, that means paying taxes upfront, but there are two benefits to this.

- 1. Take advantage of low tax rates. One is that tax rates right now are as low as they may ever be, but you would of course check this with each case. In addition, not only may tax rates increase, but left alone, the IRA balance could increase as well, resulting in a potential future higher tax rate on a higher IRA balance. That's a double tax problem, at the worst possible time, when funds are needed in retirement.
- 2. Achieve better long-term planning. The second reason why paying the taxes up front makes sense is the long-term benefit. These taxes will be forced out anyway through RMDs, either before or after death. Paying taxes now on a lower balance at a potentially lower tax rate frees up the money to do better long-term planning with permanent life insurance.

In other words, long-term, the family will end up with more wealth than they would have had with the large IRA. And more of that will be tax-free. IRAs should be leveraged, not left alone to grow a tax bill.

The first thing to do is to find out the client's short term needs. That would be for at least 10 years. If all or part of the IRA funds are not needed here, then those funds should be withdrawn and the funds remaining after taxes can be better invested for retirement in a permanent life insurance policy.

The sweet spot for this transition from IRAs to life insurance is in a client's 60's. Before age 59 ½ there is a 10 percent early distribution penalty and after 70 ½ RMDs begin, limiting some control. The long-term master plan is for the family to end up building wealth in a permanent life insurance policy, rather than building a tax debt in an IRA. The plan has to be long-term because the funds in the life insurance policy need time to grow. That should be at least a 10-year plan. The growth will be tax-free within the policy. The best part for clients: The fund is available to double as a lifetime retirement account if needed, except

that there are no RMDs and no income taxes. There is also no stock market risk due to guarantees that can be set up in the policy. There is liquidity and access for lifetime needs. Most clients are not aware of this benefit.

Then, of course, there is the death benefit, which presents an income tax-free windfall for beneficiaries. Life insurance is also a better asset to leave to a trust for beneficiaries if there are control, protection or management issues with beneficiaries. There are no mandatory RMDs from inherited life insurance.

What are the downsides to this plan?

Many say that this is a very unconventional planning technique. It shouldn't be when you see the ultimate family benefit. So what are the potential drawbacks to life insurance vs. IRAs?

The downside is that taxes are paid up front, but

much of this money will be going to the tax man anyway over time. There is no tax deduction for contributing to a life insurance policy, but as you can see from the above IRA tax problems, a deduction for an IRA contribution becomes a growing tax debt waiting to be paid.

Also, with life insurance, clients won't benefit from the upside of the stock market, but they also won't lose money, plus they can use other funds for market exposure if they wish. If those investments do produce gains, the appreciation can escape income tax at death with the step-up in basis.

Perhaps the biggest downside is that life insurance is a long-term planning solution that requires payments in the short term for larger benefits long-term. Clients have to focus on the long-term solution under both scenarios: having funds in IRAs or life insurance. At retirement and after death, life insurance wins big and the benefit widens substantially over time, without having to hope the stock market will carry the day.

All this adds up to retirement security and peace of mind, something that large IRAs cannot provide with certainty. Large IRAs need to be transitioned to tax-free territory using the tax benefits of life insurance. Permanent life insurance is a much better long-term retirement asset.

## New Deputy Supreme Knight Appointed

atrick E. Kelly, a Past State Deputy of the District of Columbia, was appointed Deputy Supreme Knight by the Knights of Columbus Board of Directors on December 13. A Knight for 33 years, Kelly became the Order's Vice President for Public Policy in 2006 and since 2011 has also served as Executive Director of the Saint John Paul II National Shrine in Washington, D.C. He was elected to the Order's Board of Directors in 2013. Earlier this year, he retired with the rank of Captain from the U.S. Navy Judge Advocate General's (JAG) Corps Reserve, where he specialized in international and operational law and served as the Commanding Officer of the international law unit at the United States Naval War College. Previously, Kelly had a long career of public service that included advisory roles to Congress and the Department of Justice. Kelly also served as Senior Advisor to the Ambassadorat-Large for International Religious Freedom at the State Department. His responsibilities included serving as the Department's principal interlocutor with the Holy See and other nations on religious freedom issues.

He succeeds Logan T. Ludwig, who is retiring at age 70 after serving as Deputy Supreme Knight since 2013. Ludwig served previously for two years as Supreme Treasurer and has been a member of the Board of Directors since 2007.

Kelly has served as the first Executive Director of the Saint John Paul II National Shrine, which is adjacent to The Catholic University of America. He has overseen the renewal of that facility, previously known as the Pope John Paul II Cultural Center, which was purchased by the Supreme Council in 2011. During his tenure, the Shrine has developed a world-class permanent exhibit, called "A Gift of Love: The Life of Saint John Paul II," and created two new worship spaces that feature the mosaic artwork of Jesuit Father Marko Rupnik — the Redemptor Hominis Church and the Luminous Mysteries



Chapel, which enshrines a first- class blood relic of St. John Paul II. As Deputy Supreme Knight, Kelly will continue to oversee the Shrine's operations.

He holds a law degree from Marquette University Law School and a master's in theology from the Pontifical John Paul II Institute for Studies on Marriage and Family at The Catholic University of America. He and his wife, Vanessa, have three young daughters.
